PUPPET ON THE STAGE

Donald Trump was president for four years from 2017 to 2020. He could not get his second term and is feeling his schedule unfinished. Naturally, he is anxious to get on to the throne again and finish his agenda. When he was contesting in 2020 there was no other person seeking nomination from the Republican Party as he was a sitting president and by convention the field was left to him. Unfortunately, he lost the election. That world by itself is not enough for him. In fact, money will not allow you to keep quiet. It tickles, stimulates, cajoles and provokes people to do something more and different. The natural corollary to money power is political power. They are interchangeable. It would not be wrong on his part to aim at it. But there is an obstacle.

Art.II of the American constitution states that "No person except a natural born Citizen or a Citizen of the United Sates at the time of adoption of this Constitution, shall be eligible to the Office of President." The constitution allows two kinds of citizenship — natural citizen and naturalized citizen. Those who are born in the United Staes are natural (born) citizens. Only those are entitled to the Office of President (consequently also of vice—President). Unfortunately, Elon Musk was born in South Africa and has become a naturalized citizen of America later like many of the immigrants. He has to search for other avenues to get into the power corridors in America. He observed the campaign of Donald Trump and felt the opportunity is there. Trump is notorious for his aggressive statements and extreme haphazard opinions that he expresses even against his

advisers. The campaign finds it difficult to justify what he says. Particularly the support from Putin has become an unjustified connection. Musk too has closer links with Putin. Strange that a capitalist has cordial connections with the head of a socialist, if not communist, state. No scruples on either side for political exigencies! Musk felt he could do better in that respect and jumped into the fray. He could save Trump from the blame of maintaining relations with an archrival from a foreign country by taking that responsibility on himself. In spite of the campaign having connections with Russia, Trump won in 2016. Why not now? Americans do not consider it wrong. They are broad minded!

He formed a Political Action Committee, the 'American PAC' with donation of \$75 million. The campaign caught fire and enlivened by that. Musk jumped on to the stage, flying in the air embraced Trump in full view of the electorate. Trump, on his part, declared that Musk would be an important part of his government if he gets elected. How big is that IF is to be seen. But Musk is ensured that he would be in official position of considerable influence if Trump is elected as president. He gets involved wholeheartedly. He would not squander his money without aim. He chose the state of Pennsylvania for his actions. While the \$75 million may be spent all over the country he devised special schemes to influence the voters in Pennsylvania. But there is a law to be respected.
